

WITHDRAWAL OF APPLICATION

("White Exploration") hereby notifies the Kansas Corporation Commission and all interested parties that it hereby withdraws its Application in the above captioned docket seeking an extension of the time limits set forth in K.A.R. § 82-3-602 to close the drilling pit for the Youngers #1 well in the NE/4 of Section 22, Township 31 South, Range 12 West, Barber County, Kansas (the "Pit"). The Pit has now been closed, White Exploration has filed KCC Form CDP-4 documenting the closure of the Pit with the Commission, and the Commission has approved that form. Thus, the relief sought in the Application is moot.

WHEREFORE, White Exploration requests that the Kansas Corporation Commission accept this withdrawal of its Application filed in the above captioned docket and that the Application be dismissed, without prejudice.

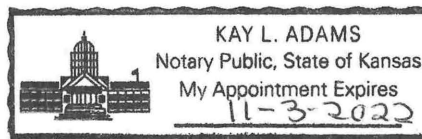
