**ORDER DESIGNATING PREHEARING OFFICER**

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

1. On December 31, 2015, Kansas City Power & Light Company (KCP&L) filed an Application with the Commission seeking approval of a Residential All-Electric Rider Tariff.
2. On January 7, 2016, the Citizens' Utility Ratepayer Board (CURB) petitioned for intervention and requested the Commission issue a Protective Order and Discovery Order in this docket.
3. On February 9, 2016, the Commission filed an Order on Protective and Discovery Orders; Electronic Service; Designating Prehearing Officer; and Granting CURB Intervention.
4. Although the Commission previously designated Dustin L. Kirk as the Prehearing Officer in this docket by Order dated February 9, 2016, at this time the Commission designates Samuel Feather, Deputy General Counsel, 1500 SW Arrowhead Road, Topeka, KS 66604-4027, telephone number (785) 271-3240, [s.feather@kcc.ks.gov](mailto:s.feather@kcc.ks.gov), to serve as Prehearing Officer in this proceeding.<sup>1</sup> The prehearing officer may conduct any prehearing conferences necessary to address any matters appropriately considered in a prehearing conference, including all items

listed in K.S.A. 77-517(b) of the Kansas Administrative Procedure Act (KAPA). The Commission may designate other staff members to serve in this capacity.


**THEREFORE, THE COMMISSION ORDERS:**
