PREHEARING OFFICER ORDER SETTING STATUS CONFERENCE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

- 1. On January 9, 2020, the Commission issued a *Penalty Order* against Operator, finding one violation of K.A.R. 82-3-107 and K.A.R. 82-3-130 because Operator did not submit a complete and accurate well completion report for the WIL #1 within 120 days of the spud date.¹ On January 31, 2020, Operator requested a hearing.² On March 3, 2020, a prehearing conference was held.³
- 2. At the prehearing conference, Operator and Commission Staff agreed to set a status conference for March 24, 2020, to allow for discussion of the possibility of resolution of this matter absent the need for a procedural schedule, and to provide Operator an opportunity to obtain counsel if necessary.

THEREFORE, THE PREHEARING OFFICER ORDERS:
