**PREHEARING OFFICER ORDER CANCELLING PREHEARING CONFERENCE**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On May 2, 2017, the Commission designated Samuel Feather as prehearing officer to address any scheduling or procedural matters pursuant to K.S.A. 77-517(b).
2. On July 17, 2017, a Prehearing Conference was held to discuss the status of the docket and the parties agreed to a continuance of the prehearing conference until September 11, 2017 at 10:00 a.m.
3. On September 6, 2017, Commission Staff (Staff) filed a Motion to Close Docket and Cancel Prehearing Conference. Based upon the content of Staff's motion, the Prehearing Officer finds the Prehearing Conference currently scheduled for Monday, September 11, 2017 at 10:00 a.m. should be cancelled.
4. The Commission will issue a separate order to address the Staff's Motion to Close Docket.

**THEREFORE, THE PREHEARING OFFICER ORDERS:**

A. The Prehearing Conference scheduled for Monday, September 11, 2017, at 10:00 a.m. by telephone is cancelled.

B. The Commission will issue a separate order to address the Staff's Motion to Close Docket.

C. Parties have 15 days, plus three additional days if mailed, from the date of service of this Order to petition for reconsideration.<sup>1</sup>

D. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it deems necessary.
