RESPONSE OF ONEOK NGL PIPELINE, L.L.C. TO STAFF'S REPORT AND RECOMMENDATION

ONEOK NGL Pipeline, L.L.C. ("ONEOK") files its response to the Kansas Corporation Commission ("Commission") Staff's ("Staff") Report and Recommendation.

- 1. On January 15, 2015, ONEOK filed an Application in Docket No. 15-ONEP-297-TAR to establish a new rate in the amount of 32.39 cpb for transporting ethane/propane mix on a proposed new route from Bushton, Kansas to Conway, Kansas. On January 30, 2015, ONEOK filed in Docket No. 15-ONEP-329-COC an Application to amend its certificate of convenience and necessity to include the new route. On Staff's motion, the Commission consolidated the two dockets on March 17, 2015.
- 2. On June 3, 2015, Staff issued its Report and Recommendation for this consolidated docket. Staff recommended that the Commission approve the proposed new rate for the new route, on the condition that ONEOK provide the Commission with an affidavit from at least one non-affiliated shipper agreeing to the rate at such time as a third party shipper becomes interested in using the new route.
 - 3. ONEOK has reviewed Staff's Report and Recommendation and concurs with the Staff's

recommendations. However, ONEOK's concurrence with the condition referenced above is specifically limited to the current consolidated dockets, and ONEOK reserves the right in future dockets, to the extent necessary, to propose alternative methods to support the reasonableness of any change in rates or rates for new services proposed by the pipeline.

WHEREFORE, ONEOK requests the Commission approve its applications subject to the recommendations made by Staff in its Report and Recommendation.
