Although not an ETC, Cingular is affected by and has an interest in the issue of whether wireless carriers should use billing address ("BA") versus primary place of usage ("PPU") in calculating KUSF assessments. Cingular has discussed this issue with Staff previously, and has presented the issue to the Commission as part of Dkt No. 04-AT&T- 926-KSF. The BA/PPU issue has broader application than just to carriers designated as ETCs.
