**ORDER ASSESSING COSTS**

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its pleadings and records, the Commission concludes the following:

1.       The Commission is authorized to assess the expenses of a proceeding, opened upon its own motion, on complaint, or upon an application to it, if the expenses attributable to the investigation exceed the sum of \$100.<sup>1</sup>

2.       Expenses attributable to this docket shall be assessed against Kansas Gas Service, a Division of ONE Gas (KGS), beginning three (3) days after the notice of assessment is given by service of this Order. KGS is hereby notified that it has the right to request a hearing regarding this assessment in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*<sup>2</sup>

**THEREFORE THE COMMISSION ORDERS:**

A.       KGS is assessed the costs of this proceeding.


