- 2. Expenses attributable to this docket shall be assessed against Kansas Gas Service, a Division of ONE Gas (KGS), beginning three (3) days after the notice of assessment is given by service of this Order. KGS is hereby notified that it has the right to request a hearing regarding this assessment in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*<sup>2</sup>

#### THEREFORE THE COMMISSION ORDERS:

A. KGS is assessed the costs of this proceeding.
