**APPLICATION**

COMES NOW, Merit Energy Company ("Merit"), by and through its attorney, Zach K. Wiggins, and in support of its Application in the above captioned matter states as follows:

1. Merit is authorized to do business in the State of Kansas, and has a street address of 13727 Noel Road, Suite 1200, Dallas, Texas, 75240.
2. The Kansas Corporation Commission has issued Merit operator's license 32446, which expires on May 30, 2025.
3. Merit is the owner and operator of the SWLVLU 45 well, which is located in the Southwest Quarter of the Northwest Quarter of the Northeast Quarter of the Southeast Quarter of Section 24, Township 30 South, Range 34 West, Haskell County, Kansas, API # 15-081-21843-00-01. The subject well is located on an active oil and gas lease or unit comprising the following lands:

Southeast Quarter of Section 24, Township 30 South, Range 34 West, Haskell County, Kansas.

4. The SWLVLU 45 was originally perforated in the Lansing Formation but watered out shortly after injection began in the SWLVLU and was shut-in as inactive.

5. Pursuant to K.A.R. 82-3-111, Merit sought and obtained temporary abandonment status for said well on or about October 21, 2011, and March 15, 2022.

6. On or about February 19, 2025, the Kansas Corporation Commission notified Merit of the KCC's denial of renewal of temporary abandonment status for the well due to the limitation period of ten (10) years imposed by K.A.R. 82-3-111.

7. K.A.R. 82-3-111 imposes a 10-year limitation on the amount of time during which wells may be temporarily abandoned, but an exception to the 10-year limitation may be obtained pursuant to said regulation through an Application filed with the Commission pursuant to K.A.R. 82-3-100. Applicant seeks such an exception.

8. Merit wishes to continue temporary abandonment status for the subject well because Merit intends to use the well as part of an enhanced oil recovery project. Merit is currently evaluating the enhanced oil recovery project. The SWLVLU 45 watered out shortly after injection began in the SWLVLU because it is structurally low. Merit would like to convert the SWLVLU 45 into an injector to add support towards the SWLVLU 47 (higher on structure) and to add boundary injection support to force injection from the SWLVLU 37 to go up structure towards the SWLVLU 35 and SWLVLU 38.

9. On April 22, 2025, the subject well passed a Commission Staff-witnessed mechanical integrity test of the casing between the surface and a point within fifty (50) feet above the uppermost perforations.

10. There are 47 wells on the lease including 24 injector wells, 19 producing wells, and 4 inactive wells. It would cost an estimated One Million Six Hundred Forty-Five Thousand Dollars (\$1,645,000.00) to plug this well and the remaining wells on the lease. A current production rate for the lease is 42 BOPD. A basic estimation of remaining reserves for the SWLVLU Waterflood Unit is 169.972 MBO gross. In order to convert the SWLVLU 45 well to an injector and tie it into the existing lines as part of an EOR project, it would cost approximately Eighty-Five Thousand Dollars (\$85,000.00) based on current prices. It would cost an estimate of Seven Hundred Fifty Thousand Dollars (\$750,000.00) based on current prices to drill and complete a replacement well.

11. Merit has included a plat map, attached as Exhibit A, showing the locations of all producing, injection, temporarily abandoned, abandoned and plugged wells located on the same lease premises as the subject well.

12. Based on the foregoing, Merit requests the Commission grant an exception to the 10-year limitation, specifically to allow the SWLVLU 45 well to remain eligible for temporary abandonment status for three (3) years following the expiration of 10-year limitation. Merit understands that the exception would be valid for three (3) years, but Merit would still need to apply annually to the Conservation Division District Office for approval of an Application for temporary abandonment status.

13. Listed in attached Exhibit B are the names and addresses of the following persons:

- A. Each operator of each oil and gas lease covering lands within one-half (1/2) mile radius of the subject well; and

B. Each person who owns any mineral interest of record in and under any lands located within one-half (1/2) mile radius of the subject well if unleased.

14. That the Applicant has sent by regular mail a copy of this Application and Notice of Pending Application to all persons listed on the attached Exhibit B.

15. Notice of this Application will be published pursuant to K.A.R. 82-3-135a.

16. WHEREFORE, Merit prays that this matter be granted administratively without a hearing, or in the alternative be set for hearing, and upon hearing that the Commission grant Merit's request for an exception to the K.A.R. 82-3-111 10-year limitation, to allow the subject well to remain temporarily abandoned for three (3) years, subject to annual approval by the Conservation Division District Office of an application for temporary abandonment status.

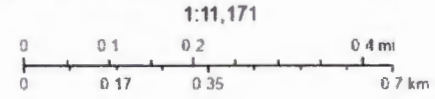


**SWLVLU 45 AOR MAP**
