#### PETITION TO INTERVENE

COMES NOW the Kansas Power Pool ("KPP"), a Municipal Energy Agency, and hereby moves the Corporation Commission of the State of Kansas ("Commission") for an Order permitting it to intervene in the above-captioned matter. In support of its Petition, KPP states and alleges as follows:

- 1. The Kansas Power Pool ("KPP"), a Municipal Energy Agency, is a quasimunicipal corporation which is authorized to do business in the State of Kansas. Attached hereto and incorporated herein by reference is a list of KPP Members (Appendix A).
- 2. On July 16, 2015, the applicants, and each of them, filed their joint Application for Commission Approval of individual 34.5 kV Formula-Based Rates.
- 3. KPP is requesting permission to intervene in this Docket to represent the interests of its members. KPP members, Greensburg and Kingman are connected to Southern Pioneer's 34.5 kV transmission system; the City of Attica is interconnected to Wheatland's 34.5 kV transmission system; and the Cities of Holyrood, Lucas and Luray are interconnected to the 34.5 kV transmission system of Prairie Land Electric Cooperative, Inc. These KPP members are served by the aforementioned 34.5 kV transmission systems and KPP pays Local Access charges that will be affected by this filing. Accordingly, KPP and its members have a justifiable interest in the outcome of this proceeding.

4. The representation of KPP's interests in this proceeding by existing parties is or may be inadequate and no party will represent the interests of municipal energy agencies or its cities, except for KPP.

5. KPP Member Cities, whose interests KPP represents, will be bound by any Commission Order or activity in this proceeding and will or may be adversely affected thereby.
