MOTION FOR A PROCEDURAL ORDER

COME NOW, Evergy Metro, Inc. (“Evergy Kansas Metro”), Evergy Kansas Central, Inc. and Evergy Kansas South, Inc. (together as “Evergy Kansas Central”) (collectively referred to herein as “Evergy” or the “Company”) and file this *Motion for A Procedural Order* (“Motion”) with the State Corporation Commission of the State of Kansas (“Commission”) requesting issuance of an Order approving the procedural schedule set forth in **Attachment A** to this Motion.

In support, Evergy states the following:

1. On September 30, 2024, Evergy filed an application in this matter seeking approval of its proposed Phase 2 Transportation Electrification Portfolio.
2. On November 5, 2024, the Citizens’ Utility Ratepayer Board (“CURB”) was granted intervention.
3. It is anticipated that activities in this docket will commence right away, with a Technical Conference proposed to be held in December. As such, Evergy has worked collaboratively with the Commission Staff and CURB on a procedural schedule for this case. An agreed schedule has been developed and is included with this Motion as **Attachment A**.
4. Evergy hereby requests the Commission approve the schedule as set forth in **Attachment A**.

WHEREFORE, Evergy respectfully requests the Commission grant this Motion and issue a Procedural Order as set forth in **Attachment A**.
