COMES NOW, Pickrell Drilling Co., Inc., ("Pickrell") and hereby moves to withdraw its protest without prejudice to the Application of Palomino Petroleum, Inc. ("Palomino") for a well location exception as captioned above. In support of its withdrawal of its protest, Pickrell states as follows:

1. The Motion to Intervene and Protest of Pickrell was filed in this matter on January 27, 2021. The Application of Palomino seeks an Order for a well location exception.
