PRESIDING OFFICER ORDER SETTING PROCEDURAL SCHEDULE

The Presiding Officer finds and concludes as follows:

1. At the July 21, 2022, prehearing conference, Operator stated its intention to file a motion on or before July 29, 2022, to close this docket. Operator is directed to file any such motion on or before such date; Staff's response shall be due by August 10, 2022.

2. Parties also agreed to the following procedural schedule, which is hereby adopted:

Commission Staff Pre-Filed Direct Testimony	Due: September 9, 2022
Operator Pre-Filed Direct & Rebuttal Testimony	Due: September 16, 2022
Commission Staff Pre-Filed Rebuttal Testimony	Due: September 30, 2022
Evidentiary Hearing before the Commission:	To Be Determined

3. The Presiding Officer shall be in communication with the parties regarding any further development of the procedural schedule, including scheduling of any evidentiary hearing.

4. Failure to submit pre-filed testimony may result in the Commission restricting the right to testify and present evidence at the evidentiary hearing. At the hearing, the Commission may limit the parties' direct and rebuttal testimony to the pre-filed testimony.

5. Any person requiring special accommodations under the Americans with Disabilities Act should notify the Commission at least 10 days before the scheduled hearing date.

5. Any party who fails to attend or participate in the evidentiary hearing or any other stage of this proceeding may be held in default under the Kansas Administrative Procedure Act.¹

6. Parties shall appear before the Commission via a Kansas-licensed attorney.²
