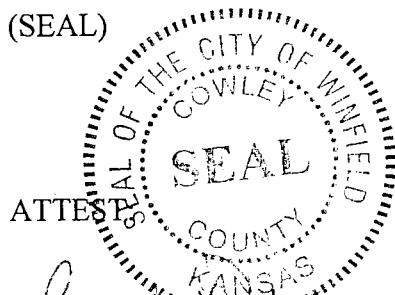
**THEREFORE**, be it resolved by the governing body of the City of Winfield, Kansas that:
