## ORDER AMENDING VIDEO SERVICE AUTHORIZATION TO INCLUDE THE CITY OF TORONTO, KANSAS

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

1. On September 11, 2012, MMC Missouri LLC d/b/a Mediacom (MMC) filed an Amended Application for its state-issued Video Service Authorization, as authorized by K.S.A. 2011 Supp. 12-2023(a) and K.A.R. 82-15-1, to include within its approved areas, the city of Toronto, Kansas.

2. MMC was previously granted video service authorization in nine (9) communities in Kansas pursuant to Commission Orders issued in this docket on January 20, 2011, September 22, 2011, October 13, 2011, and March 13, 2012.

3. On October 1, 2012, Staff submitted its Report and Recommendation dated September 27, 2012, recommending Commission approval of MMC's Amended Application.

4. Staff states that MMC is a foreign limited liability company properly registered with the Kansas Secretary of State's office and that the company's status with that office is "active and in good standing". Staff further states that MMC is registered with the Federal

Communications Commission (FCC) as a Cable System Operator under the following Community Unit Identification Number (CUID):

5. By initialing, MMC in its initial filing in this docket on December 30, 2010, agreed to comply with all applicable federal and state statutes and regulations and agrees to comply with all lawful and applicable municipal regulations regarding the use and occupation of public rights-of-way in the delivery of video services, including the police powers of the municipalities in which the service is delivered. (Application item 5).

6. MMC's proposed service area is described as:

The City of Toronto, in Woodson County, Kansas:

Township 26S, Range 13E, Sections 11 and 12

MMC has provided the foregoing description in an electronic format, compatible with the Commission's mapping system. For ease of future reference, Staff identifies MMC's area footprint as: TRNT-10-MMOC-01. According to Staff, MMC is the incumbent provider and currently passes 100% of the households. MMC has provided a high level drawing of its hybrid fiber/coax network configured in a ring and spoke configuration. Staff recommends Commission approval of MMC's Application, with the company's additional service area footprint to be identified and known as Toronto, TRNT-10-MMOC-01. Report and Recommendation at page 2.

7. The Commission finds it has jurisdiction to consider applications for Video Service Authorization pursuant to K.S.A. 2011 Supp. 12-2023. Pursuant to the authority granted to the Commission by K.S.A. 2011 Supp. 12-2023, the Commission finds that MMC's Amended Application meets the requirements of the statute and K.A.R. 82-15-1. The Commission adopts Staff's recommendation of September 25, 2012, as stated in its Report and Recommendation, which is attached hereto and made a part hereof by reference, and finds that MMC's Application should be granted and MMC's proposed service area footprint approved.

#### IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. MCC Missouri LLC d/b/a Mediacom's Amended Application for state-issued Video Service Authorization is hereby granted and its proposed additional service area footprint is hereby approved, to be identified and known as Toronto, TRNT-10-MMOC-01.

B. The parties have fifteen (15) days, plus three (3) days if service of this Order is by mail, from the date this Order was served in which to petition the Commission for reconsideration of any issue or issues decided herein. K.S.A. 66-118b; K.S.A. 2011 Supp. 77-529.

C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further order, or orders, as it may deem necessary.

## **EXECUTIVE SUMMARY:**

On September 11, 2012, MMC Missouri LLC d/b/a Mediacom (MMC) filed an Amended Application for its state-issued Video Service Authorization, as authorized by K.S.A. 12-2023 and K.A.R. 82-15-1.

In accordance with K.S.A. 12-2023(a), Commission action in this matter is required not later than **Thursday, October 11, 2012**.

#### **BACKGROUND:**

The Applicant has previously been granted video service authorizations in nine communities in Kansas. This amended filing seeks to expand previously granted authority to include the city of Toronto, Kansas.

## ANALYSIS:

The Applicant has reaffirmed its principal place of business as 100 Crystal Run Road, Middletown, N.Y., 10941, and has previously provided its officers and contact personnel<sup>1</sup>.

The Applicant is registered with the Kansas Secretary of State's office as a Foreign Limited Liability Company and is currently 'Active and in Good Standing' with the Secretary's office.

The Applicant has provided the above description in an electronic format, compatible with the Commission's mapping system.

For ease of future reference, staff is identifying<sup>3</sup> the proposed footprint as follows: TRNT-10-MMOC-01.

The Applicant states that it is the incumbent provider and currently passes 100% of the households.

The Applicant has provided a high level drawing of its hybrid fiber/coax network configured in a ring and spoke configuration.

#### **RECOMMENDATION:**
