In support of its motion, Consumers show the Commission as follows:

1. On August 28, 2019, Consumers filed its formal complaint in this proceeding against Westar Energy, Inc. (now known as Evergy Kansas Central, Inc.; “Evergy”), which was accepted by the Commission on September 12, 2019.
2. On October 7, 2019, Evergy filed its Answer to the Complaint.
3. On March 5, 2020, Staff filed its Report and Recommendation.
4. On March 9, 2020, Evergy filed its Response to Staff’s Report and Recommendation.
5. By Consumers’ calculation, our Response to Staff’s Report and Recommendation, is due on March 19, 2020. As we are dealing with a possible disconnection of service from Evergy as well as reviewing Staff’s Report and Recommendation and Evergy’s Response to it, Consumers simply need additional time to draft its Response. Consumers respectfully request this enlargement of time in which is to file its Response to Staff’s Report and Recommendation

from Thursday, March 19, 2020, to and including Monday, March 30, 2020.



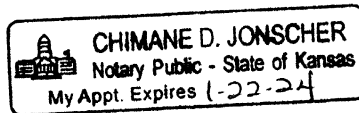


