**MOTION TO CLOSE DOCKET**

Commission Staff (Staff) of the State Corporation Commission of the State of Kansas  
(Commission) files this Motion to Close Docket. In support of its motion, Staff states as follows:

**I. Background**

1. On July 19, 2017, Staff filed a motion for an order to show cause, alleging that Operator was out of compliance with Commission statutes and regulations because two unplugged wells remained on its expired license.


2. On August 22, 2017, the Commission issued an Order to Show Cause, setting a September 14, 2017, prehearing conference, which was subsequently continued to November 9, 2017, via a prehearing officer order.

**II. Motion**

3. Staff has determined that both the wells at issue in this docket have now been plugged. The matter at issue has thus now been resolved, and so Staff now moves the Commission to close this docket. Staff notes that closure of this docket would render the scheduled prehearing conference unnecessary.

WHEREFORE, for the reasons described above, Staff respectfully moves the Commission to close the docket.





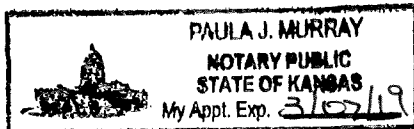
