COMES NOW Merit Energy Company, LLC, 13727 Noel Road, Suite 1200, Dallas, TX 75240, Applicant herein and respectfully states to the Commission as follows:

1. The Applicant is the owner of oil and gas leasehold interests and operates numerous wells located in Finney County, Kansas.

2. The Applicant proposes to drill the River Bend 4 at a location of 612 feet from the North line and 180 feet from the West line of Section 35, Township 24 South, Range 32 West, Finney County, Kansas, and complete the well in the St. Louis formation.

3. That the River Bend 4 well will not be drilled at a regular location as prescribed by K.A.R. 82-3-108 in that it will be closer than 330 feet from a lease boundary line.

4. That the Applicant seeks to drill the River Bend 4 well at the requested location in order to maximize its geological position and encounter a narrow channel in the St. Louis formation and maximize recovery from the St. Louis formation in the subject area.

5. The St. Louis formation is not subject to a special order or basic proration order of the Commission and as such a standard drilling unit is established by K.A.R. 82-3-207 as ten acres. Applicant seeks to assign a full ten acres to the River Bend 4 well and to receive a full allowable therefor.

6. That the Applicant has a market for the subject well and the production and sale from the River Bend 4 well will be in accordance with the rules and regulations

of the Commission and for purposes permitted by the laws of the State of Kansas so as not to constitute waste.

7. That there are no unleased offset mineral owners. Applicant is the offset operator. Attached as Exhibit "1" is a listing of the names of Applicant's lessor(s) in the lease operated by Applicant that is situated less than the minimum distance from the proposed well location.

8. That the Applicant has sent by regular mail a copy of this Application and Notice of Pending Application to all persons listed on the attached Exhibit "1".

9. That attached hereto and made a part of this Application marked Exhibit "2" is a Plat showing the property on which the River Bend 4 well is sought to be drilled and completed, partially drilled or permitted wells on the property and all adjacent property and wells.

10. That Applicant is causing the Notice of this Pending Application to be published as required by the Commission, in *The Wichita Eagle* and *The Garden City Telegram* newspapers. Said Notice provides that unless a written protest is received by the Commission within 15 days after the date of publication of said Notice, the Application in this matter will be granted administrative approval after the 15-day period.

WHEREFORE, Applicant prays that this cause be docketed and, in the event, that no protest is made to the Commission within the time period provided, an Order be entered granting the location exception and assignment of a full allowable at the appropriate time to the River Bend 4 well and that Applicant be permitted to drill the well and complete in the St. Louis formation.


