13, 1999.


3. CURB is in the midst of a hearing the week of March 15<sup>th</sup> which will continue to

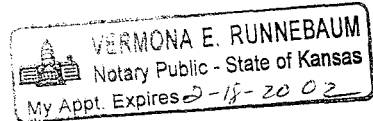


