II.



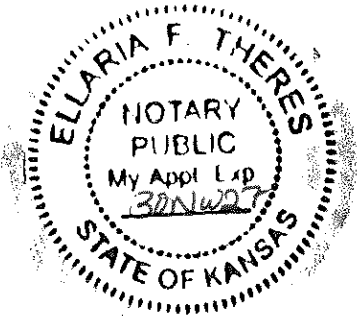
