PREHEARING OFFICER ORDER SETTING PROCEDURAL SCHEDULE

1. The Prehearing Officer finds that a procedural schedule should be established. At a prehearing conference held on November 3, 2015, all parties agreed to the following schedule:

Staff's Pre-filed Direct Testimony	Due by December 28, 2015
Appellant's Pre-filed Direct Testimony	Due by January 4, 2016
Staff's Pre-filed Rebuttal Testimony	Due by January 11, 2016
Evidentiary Hearing before the Commission	January 21, 2016, 10:00 a.m.

2. Parties should note the following:
- Failure to submit pre-filed testimony will likely result in the Commission restricting the right to testify and present evidence at hearing.
 - At hearing, the Commission may limit direct and rebuttal testimony to the pre-filed testimony.
 - Any settlement agreement the parties wish to present for the Commission's consideration shall be due by January 11, 2015.

- d. Any person requiring special accommodations under the Americans with Disabilities Act is asked to give notice to the Commission at least 10 days prior to the scheduled hearing date.


