### **MOTION TO CLOSE DOCKET**

The Staff of the State Corporation Commission of the State of Kansas ("Staff" and "Commission," respectively) files this *Motion to Close Docket*.

- 1. On May 5, 2017, L & G Petroleum Operating, LLC (Operator) submitted a license application. The same day, Staff denied Operator's license application because of Operator's association with Equinox Oil Company, License #9312, which is not in good standing with the Commission. Operator requested a hearing.
- 2. On June 22, 2017, the Commission issued an order setting a prehearing conference for August 24, 2017. The prehearing conference has been continued several times, with a status conference most recently held March 1, 2018. At the moment, no prehearing conference is scheduled and no procedural schedule has been issued.
- 3. Pursuant to K.A.R. 82-3-120(h) and Commission policy, Staff has approved Operator's application and has issued Operator's license.

WHEREFORE, as no issues remain to be resolved, Staff moves this docket to be closed.


