- 1. On April 5, 2019, L.D. Drilling Inc. ("Operator") submitted an application seeking an exception to the pit closure time limitation of K.A.R. 82-3-602.
- 2. On June 13, 2019, the Operator filed a letter requesting the withdrawing the application. The letter stated that the Operator closed the pit on April 23, 2019.<sup>2</sup>
- 3. In light of the Applicant's withdrawal of the Application, the Commission finds further proceedings are unnecessary, this docket should be closed.

## THEREFORE, THE COMMISSION ORDERS:

- A. This docket is closed.
- B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).<sup>3</sup>
- C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it may deem necessary.
