ORDER CLOSING DOCKET

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises the Commission finds and concludes as follows:

1. On April 5, 2019, L.D. Drilling Inc. (“Operator”) submitted an application seeking an exception to the pit closure time limitation of K.A.R. 82-3-602.¹
2. On June 13, 2019, the Operator filed a letter requesting the withdrawing the application. The letter stated that the Operator closed the pit on April 23, 2019.²
3. In light of the Applicant’s withdrawal of the Application, the Commission finds further proceedings are unnecessary, this docket should be closed.

THEREFORE, THE COMMISSION ORDERS:

- A. This docket is closed.
- B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).³
- C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it may deem necessary.
