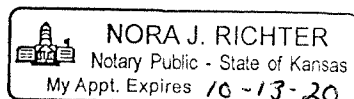

You are hereby notified that Prairie Energy, LC ("Applicant") has filed an application with the Kansas Corporation Commission ("Commission") requesting an exception to the ten-year temporary abandonment time limitation of K.A.R. 82-3-111(b) for its Snell #2 gas well located in the Southwest Quarter (SW/4) of Section 35, Township 22 South, Range 38 West, Kearny County, Kansas, approximately 1,320' from the South line and 3,960' from the East line of said section. The Subject Well is located on an active oil and gas lease that has been consolidated to form a basic proration unit for the Hugoton/Panoma Council Grove Field comprised of the S/2 of Section 27, the NE/4 of Section 34, and the SW/4 of Section 35, all in Township 22 South, Range 38 West, Kearny County, Kansas. Applicant is the operator of the Snell #2 well.

The application is pending with the Commission. Any persons who object or protest to such application shall be required to file their objections or protests in writing with the Commission within 15 days from the last date of this publication. If a written protest is not timely filed, the application may be granted by the Commission without hearing or further notice to any interested party. All objections and protests shall clearly state the reasons why granting the application will violate correlative rights, cause waste or pollution. Objections or protests shall be mailed to the Kansas Corporation Commission, Conservation Division, 266 N. Main St., Ste. 220, Wichita, KS 67202, with a copy to Applicant's attorneys listed below. All parties in any way interested or concerned shall take notice of the foregoing and govern themselves accordingly.
