STAFF'S MOTION TO DISMISS

The Staff of the State Corporation Commission of the State of Kansas (Staff and Commission, respectively) by and through its counsel Robert E. Vincent presents the abovecaptioned matter to the Commission for dismissal of the enforcement action, with prejudice, against Custom Limousine, Inc. of Bonner Springs, Kansas. In support of its Motion, Staff states as follows:

1. On or about June 5, 2014, Kansas Highway Patrol Technical Trooper Wright conducted a "Level I – Full" inspection on a commercial motor vehicle operated by Custom Limousine, Inc. The inspection was documented in Driver / Vehicle Examination Report Number KS00MX000931.

2. On or about June 10, 2014, the Kansas Highway Patrol issued a Notice of Violation and Invoice against Custom Limousine, Inc. of Bonner Springs, Kansas, assessing fines for violations found during a June 5, 2014, routine motor carrier stop and inspection conducted by the Kansas Highway Patrol. The Notice of Violation and Invoice was documented with Kansas Corporation Commission Invoice No. H000548536.

3. On August 4, 2014, Custom Limousine, Inc. filed a request for hearing. 4. After further review of this matter, Staff recommends that the above enforcement action be dismissed with prejudice as Staff believes it has insufficient evidence to proceed at this time.

5. Likewise, Staff recommends that the \$150.00 civil assessment identified in Kansas Corporation Commission Invoice No. H000548536 be dismissed.

6. Staff further recommends that the above-referenced docket be closed.

WHEREFORE, for the reasons set forth above, Staff respectfully requests the Commission find that the above enforcement action against Custom Limousine, Inc. of Bonner Springs, Kansas, be dismissed with prejudice, that the outstanding civil assessment proposed against Custom Limousine, Inc. be dismissed, and that the docket be closed.
