





I. COX MEETS THE REQUIREMENTS TO AMEND ITS CERTIFICATE OF CONVENIENCE AND AUTHORITY TO SERVE THE WAMEGO AND ST. GEORGE EXCHANGES

1. On May 4, 2000, Cox Kansas Telcom, LLC, was granted a Certificate of Convenience and Authority (“Certificate”) to offer local exchange telecommunications service and exchange access service throughout the service areas of Southwestern Bell Telephone
