**APPLICATION FOR A CERTIFICATE OF PUBLIC CONVENIENCE AND  
AUTHORITY TO TRANSACT THE BUSINESS OF AN ELECTRIC PUBLIC UTILITY**

COMES NOW, Evergy Kansas South, Inc. d/b/a Evergy Kansas South (“Evergy Kansas South”), and in support of its *Application for a Certificate of Public Convenience and Authority* (“Application”), states as follows:

1. Evergy Kansas South is a Kansas corporation authorized by the Commission to conduct the business of a public utility under the provisions of K.S.A. 66-104, and as such holds a Certificate of Convenience and Authority from this Commission to engage in the business of an electric public utility in the State of Kansas, thereby promoting the public convenience. Evergy Kansas South seeks to serve, subject to the Commission’s approval, in Butler Rural Electric Cooperative Association, Inc. (“Butler Rural”) certified territory described below:

**SEDGWICK COUNTY, KANSAS**

A tract of land that is located in the Southern ½ of the West ½ of the North ½ of the Northwest ¼ in Township 26S, Range 02E, Section 36 of Sedgwick County, Kansas. See Exhibit A.

2. Evergy Kansas South’s certified territory is adjacent to the territory described in paragraph 1.

3. Both Evergy and Butler Rural have assets about ¼ mile away that would feed the proposed house location. It would be more feasible for the customer for Evergy to serve the home.

4. Evergy Kansas South and Butler Rural have mutually agreed, subject to the Commission's approval, that Evergy Kansas South should serve as an electric public utility in the territory described in paragraph 1.
