MOTION TO LATE-FILE TESTIMONY

COMES NOW Walmart Inc, by and through under-signed counsel, and for its Motion to Late-File Testimony respectfully states as follows:

1. On June 19, 2018, the Commission issued its Order calling for the filing of cross-answering testimony in this case on June 22, 2018 at noon.
2. As a result of problems accessing the internet, counsel was unable to meet the noon deadline. Instead, after resolving these problems, counsel filed Walmart's cross-answering testimony at 3:00 p.m.
3. While Walmart technically missed the deadline for filing testimony, it believes that the Commission granting a motion to late-file testimony will not significantly prejudice any party. Specifically, since this is cross-answering testimony, only Westar is allowed to file rebuttal testimony in response to this testimony. Recognizing that Walmart's cross-answering testimony supported Westar's position on the allocation of fixed production costs, the late-filing of the testimony should not be prejudicial to Westar's interests.

WHEREFORE, Walmart respectfully requests that the Commission grant this motion to late-file cross-answering testimony.
