- 1 Q. Please state your name.
- 2 A. My name is Dow Morris.
- 3 Q. By whom are you employed and what is your business address?
- 4 A. I am employed by Lane-Scott Electric Cooperative, Inc. ("Lane-Scott"). My
- 5 business address is 410 South High Street, Dighton, Kansas.
- 6 Q. Would you summarize your educational background?
- 7 A. I graduated from Illinois State in 1981 with a degree in accounting.
- 8 Q. Please summarize your work experience.
- 9 A. I have worked for an electric cooperative for the past 26 years primarily in the
- 10 accounting, finance and management areas. I currently serve as Assistant
- 11 General Manager for Lane-Scott.
- 12 Q. Are you also an officer of Mid-Kansas Electric Company, LLC?
- 13 A. No. However, I served as an alternate on the Board of Directors of Mid-Kansas
- 14 Electric Company, LLC ("Mid-Kansas") from March, 2012 through November,
- 15 2012.
- 16 Q. What is the purpose of your testimony?
- 17 A. The purpose of my testimony is to provide background information on Lane-Scott
- and support for relief sought in the Joint Application filed by Mid-Kansas and its
- 19 Members<sup>1</sup>, including Lane-Scott.

'		1. HISTORICAL INFORMATION ON LANE-SCOTT
2	Q.	Please provide an overview of your testimony.
3	A.	My testimony will primarily focus on a brief overview of Lane-Scott and
4		determination of the process for exemption from regulation.
5	Q.	Please provide a brief overview of Lane-Scott.
6	A.	Lane-Scott is an electric cooperative formed under the Kansas Electric
7		Cooperative Act. It was formed for the purpose of supplying electric energy and
8		promoting and extending the use of such energy in rural areas of western
9		Kansas. Lane-Scott was formed in 1941. Lane-Scott, therefore, has been
10		providing electric retail service in the western Kansas for over 61 years.
11	Q.	Would you provide a summary of the service area and the nature of service
12		Lane-Scott provided before the acquisition on Aquila-WPK by Mid-Kansas?
13	A.	Prior to the acquisition, Lane-Scott provided electric retail services in seven
14		counties, with approximately 2,800 meters. Its service territory runs from Ness
15		and Hodgeman counties on the eastern end to the Scott and Finney counties on
16		the western end. Lane-Scott also served various cities within its certificated
17		territory. Although it did not operate generation or transmission lines, it operated
18		and maintained approximately 1,700 miles of distribution lines.
19	Q.	Would you provide a summary of the area served and scope by Lane-Scott
20		after the acquisition of the Aquila-WPK by Mid-Kansas?
21	A.	After the acquisition, pursuant to a service contract with Mid-Kansas, Lane-Scott
22		increased the number of total meters to approximately 5,700 and continues to

serve approximately that number of meters in the Lane-Scott division. Through
the acquisition, the service territory was extended easterly to approximately the
western one-half of Rush County from the eastern edge of the original LaneScott service territory. With the acquisition of Aquila-WPK, the number of meters
served is approximately 5,700.

- Q. Prior to the acquisition, was Lane-Scott a deregulated cooperative?
- 7 A. Yes. In 1994, the member customers of Lane-Scott voted to deregulate. Of the
  8 member customers voting, 81% approved the deregulation of Lane-Scott. Since
  9 that date, Lane-Scott has operated as a deregulated cooperative. The
  10 deregulation of the cooperative has allowed the member owners to govern
  11 themselves with far less expense than Lane-Scott could otherwise have done
  12 had it continued to be regulated.
- Q. Why did the six Members of Mid-Kansas elect to pursue the acquisition ofAquila-WPK?
  - A. As was true with other members, Lane-Scott saw the acquisition as an opportunity to increase its service territory and serve more residential customers. Lane-Scott was next door to Aquila-WPK's service territory. The expansion into this territory could be done at far less of a cost to Lane-Scott than any other utility as we were already serving in the general area. It allowed Lane-Scott to increase the number of customers it serves and spread costs across a larger body of customers. There were a number of synergies associated with the acquisition, all of which resulted in cost savings to both Lane-Scott's existing customers and those customers acquired in the acquisition.

- 1 Q. Do you believe the synergies that you anticipated have been realized?
- 2 A. Yes. We firmly believe the acquisition has been good for both the existing and
- acquired customers. There have been cost savings as anticipated, and the
- 4 increases in cost have been slowed as a result of the synergies and ability to
- 5 spread costs across a larger segment of customers. Also, the diversity in
- 6 customers has been beneficial as economic conditions change throughout west
- 7 central Kansas. The territory acquired by Mid-Kansas was more residential in
- 8 nature than the customer base served by Lane-Scott in its certificated territory.
- 9 The diversity has helped in stabilizing load.
- 10 Q. Do you believe Lane-Scott is capable of succeeding to a portion of Mid-
- 11 Kansas' certificated service territory as contemplated in the application?
- 12 A. Yes. Lane-Scott has been serving the customers in the Lane-Scott division since
- the acquisition in 2007. We have great confidence in our ability to service the
- customers and provide quality electric services and believe it would be in the
- best interest of the public to do so.
- 16 Q. Is Lane-Scott asking the Commission to approve the transfer of the
- 17 territory Lane-Scott is currently serving pursuant to its service contract
- 18 with Mid-Kansas?
- 19 A. Yes.
- 20 2. DETERMINATION OF PROCESS FOR EXEMPTION FROM REGULATION
- 21 Q. The application requests the determination of the process the Members are
- 22 to follow upon transfer of a Certificate to exempt themselves from

regulation under K.S.A. 66-104d. Would you explain why the applicants are seeking approval of this process?

- A. Lane-Scott was deregulated prior to the acquisition and is currently deregulated.

  Our member owners overwhelmingly supported the election to exempt themselves from regulation. Of the members voting, 81% approved the election to deregulate. Because the member owners exempted themselves from regulation, they have enjoyed the benefits of reduced regulatory costs. Plus the owners are much better at determining their needs and the rate needed to provide affordable and reliable service to themselves. Lane-Scott's Board of Directors has done a very good job of controlling rates, which we think has been validated by the member owners' satisfaction with being deregulated.
- Q. You recall that in the acquisition docket, the Members stipulated the steps for deregulation upon transfer of the Certificate of Convenience. Why are the applicants now seeking a modification to that procedure?
  - The stipulation provided that the Aquila-WPK customers were to be given full cooperative membership rights. Lane-Scott, upon the acquisition, granted all of the former Aquila-WPK customers full cooperative membership rights, including the right to vote and the right to patronage. Therefore, we have already met part of the requirement of the stipulation. The remainder of the stipulation requires a vote by the Aquila-WPK customers to determine whether they should exempt themselves from regulation. The vote is limited to only those customers in the former Aquila-WPK certificated territory being transferred to Lane-Scott. Although we are optimistic such a vote would be in favor of exemption, a vote disapproving

deregulation would raise serious questions as to the impact on the customers currently deregulated. As Mr. Lowry has stated, the statute does not contemplate a partial deregulation of the cooperative's members. As to its member owners, the cooperative is either regulated or not regulated. Our Board of Directors does not believe it would be fair or equitable to force our member owners that are currently satisfied with the deregulated status of Lane-Scott to become regulated based upon a vote of a portion of its customers. Plus, as Mr. Lowry has pointed out, the statute does not allow another vote for a period of two years. Disapproval would subject Lane-Scott's current customers to regulation for a two-year period before another vote could be taken during which Lane-Scott would incur costs of regulatory oversight.

## Q. Does Lane-Scott have a recommended solution?

Yes. We seek the modification to the Order issued in the 524 Docket to provide that to the extent any Member cooperative is exempt from regulation at the time of the transfer of the Certificate, the Member cooperative would remain unregulated subject to customers of not less than 10% of the members of the cooperative petitioning for a re-vote on deregulation. Certainly, this would be consistent with past transfer of service territory between various cooperatives. In those instances, transferred customers come in to the new cooperative subject to the current regulatory status of the cooperative to which they have been transferred. Additionally, Lane-Scott believes the ability of the former Aquila-WPK customers to petition for a vote provides adequate relief, is fair to the currently deregulated customers, and falls within the spirit of the stipulation.

- 1 Q. Does this conclude your testimony?
- 2 A. Yes.


