### **SUSPENSION ORDER**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having examined its files and records, and being duly advised in the premises, the Commission makes the following findings:

- 1. On August 6, 2012, Mid-Kansas Electric Company, LLC (Mid-Kansas) filed an Application with the Commission seeking changes to Mid-Kansas' rate schedules for the geographic service territory served by Lane-Scott Electric Cooperative, Inc. (Lane-Scott).
- 2. Commission Staff (Staff) has determined that an additional 240 days is needed to fully review Mid-Kansas' Application and suspension is required to allow sufficient time for Staff's review and investigation of this matter.
- 3. The Commission finds and concludes that suspension of the Application and deferral of its effective date are required to allow sufficient time for full investigation of this matter. The Application should be suspended for a period of 240 days from the date the application was made, August 6, 2012, until Wednesday, April 3, 2013, pursuant to K.S.A. 66-117(c).

### IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. Pursuant to K.S.A. 66-117(c), the application in the above-captioned docket shall be suspended and the effective date deferred until April 3, 2013.

- B. The parties have fifteen days, plus three days if service of this Order is by mail, from the date of service of this Order in which to request rehearing on any matter decided herein. K.S.A. 66-118b, K.S.A. 2011 Supp. 77-529(a)(1).
- C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further order, or orders, as it may deem necessary.
