ORDER

NOW, the above-captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission"). Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

1. On May 25, 2007, Southwestern Bell Telephone, L.P., d/b/a SBC Kansas ("SWBT") filed for approval of a modification to the interconnection agreement between it and MCImetro Access Transmission Services, LLC ("MCImetro"). The modification amends the agreement to further extend the amendment superseding certain reciprocal compensation, interconnection, and trunking terms through July 31, 2007. The amendment was previously approved by the Commission in this docket on October 26, 2005.

2. This agreement, with the modification and the attachments incorporated therein, is an integrated package and is the result of negotiation and compromise. There are no outstanding issues between the parties that need the assistance of mediation or arbitration. The parties seek Commission authority as required by the Federal Telecommunications Act of 1996.

3. SWBT believes approval of the modification is consistent with the public interest, convenience and necessity.

4. The Commission finds and concludes that the modification to the previously approved Interconnection Agreement between Southwestern Bell Telephone, L.P. d/b/a SBC Kansas and MCImetro Access Transmission Services, LLC should be granted. The implementation of the modification is consistent with the public interest, convenience and necessity and does not, on its face, discriminate against any telecommunications provider not a party to the agreement.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. The May 25, 2007 application of Southwestern Bell Telephone, L.P. d/b/a AT&T Kansas for approval of a modification to its interconnection agreement with MCImetro Access Transmission Services LLC, as set forth above, is hereby approved.

B. The parties have fifteen days, plus three days if service of this order is by mail, from the date this order was served in which to petition the Commission for reconsideration of any issue or issues decided herein. K.S.A. 66-118; K.S.A. 2006 Supp. 77-529(a)(1).

C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of issuing such further order, or orders, as it may deem necessary.
