### ORDER NUNC PRO TUNC

NOW, the above-captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission") for consideration and decision. Having reviewed its files and records and being duly advised in the premises, the Commission makes the following findings:

- 1. On September 21, 2017, the Commission issued an *Order Approving Amended Video Service Authorization* (Order) which approved an Application submitted by Google Fiber Kansas, LLC (Google Fiber) to amend its Video Service Authorization pursuant to K.S.A. 12-2023 and K.A.R. 82-15-1.
- 2. On September 27, 2017, Google Fiber submitted a *Notice of Errata Filing* explaining that when it submitted its amended service area information it accidentally referenced Mission Hills, Kansas, rather than Mission Woods, Kansas. However, the legal descriptions and mapping data accurately reflected Mission Woods, Kansas. Google Fiber explained that its error was clerical in nature, and requested that the Commission issue an Order Nunc Pro Tunc to correct the error.
- 3. The Commission finds that granting Google Fiber's request is appropriate and hereby substitutes all references to Mission Hills, Kansas with Mission Woods, Kansas in its

Order. The reference to Mission Hills, MSHL-07-GFKC-01 shall also be substituted with Mission Woods, MSWD-04-GFKC-01.

## IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. Google Fiber's request for an Order Nunc Pro Tunc, as explained above, is granted.

B. The parties have fifteen (15) days, plus three (3) days if service of this order is by mail, from the date this order was served in which to petition the Commission for reconsideration of any issue or issues decided herein. K.S.A. 66-118b; K.S.A. 77-529(a)(1).

C. The Commission retains jurisdiction over the subject matter and parties for the purpose of issuing such further order, or orders, as it may deem necessary.
