MOTION TO CONTINUE PROCEDURAL SCHEDULE

Staff of the State Corporation Commission of the State of Kansas (Staff and Commission, respectively) hereby requests that the procedural schedule in this docket be continued for two weeks. In support of its Motion, Staff states as follows:

1. On August 12, 2021, the Commission issued a Presiding Officer Order Setting Procedural Schedule, thereby setting deadlines for Staff and Operator to file pre-filed direct and rebuttal testimonies. Staff's pre-filed direct testimony is due September 27, 2021. However, Staff anticipates that this matter will be settled shortly, and settlement would render Staff's testimony unnecessary. Accordingly, Staff requests that its pre-filed direct testimony deadline be continued to October 11, 2021. Furthermore, Staff requests that Operator's pre-filed direct and rebuttal testimony be continued to November 1, 2021, and Staff's pre-filed rebuttal testimony be continued to November 15, 2021. Staff has conferred with Operator's counsel, who is not opposed to the continuance.

WHEREFORE, for the reasons set forth above, Staff respectfully requests that the procedural schedule in this matter be continued.
