**MOTION TO SCHEDULE PREHEARING CONFERENCE**

The Staff of the State Corporation Commission of the State of Kansas ("Staff" and "Commission," respectively) moves for an Order scheduling a prehearing conference in this matter for Friday, August 25, 2017, at a time of the Prehearing Officer's choosing.

1. On April 6, 2017, Berexco LLC ("Applicant") filed an Application for an order authorizing the unitization and unit operation of its proposed Kane Unit in Kiowa County, Kansas, pursuant to K.S.A. 55-1301, *et seq.*<sup>1</sup>

2. On May 1, 2017, the Commission received a letter from Linda Kraus ("Protestant") requesting a hearing on the Application.<sup>2</sup>

3. On May 23, 2017, the Commission set a July 17, 2017, prehearing conference. At the prehearing conference, unattended by Applicant, the Prehearing Officer directed the parties to engage in conversation and to recommend a date for another prehearing conference.


4. On July 20, 2017, Applicant, Protestant, and Staff engaged in conversation about this matter. During the conversation, Staff stated its intention to request a prehearing conference to be held on Friday, August 25, 2017, at a time of the Prehearing Officer's choosing. Applicant and Protestant stated they were not opposed to such a request.
