ORDER GRANTING STAFF'S MOTION TO CANCEL HEARING ON STAFF'S MOTION TO COMPEL

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

- 1. On April 12, 2021, Commission Staff (Staff) filed a Motion to Compel against Sprint Communications Company LP (Sprint) seeking full responses to: (1) DR 17, which requests an explanation for the variances in revenues reported from month-to-month during Fiscal Years 22, 23, and 24;¹ and (2) DR 18, which requests an explanation of discrepancies between Sprint's reported intrastate retail revenue in its 2018 CRW and 2018 Revised CRW and the 2018 Annual Report Sprint filed with the Commission.²
- 2. On May 11, 2021, the Commission issued an Order Designating Presiding Officer and Setting Hearing on Staff's Motion to Compel, scheduling a hearing on Staff's Motion to Compel for May 21, 2021, beginning at 10:00 a.m.

On May 17, 2021, Staff filed a Notice of Withdrawal and Cancellation of Hearing, advising the Commission that Sprint has provided responses to DR Nos. 17 and 18, resolving the discovery dispute.³ Therefore, Staff withdraws its Motion to Compel and requests cancellation of the May 21, 2021 hearing. Since Staff has withdrawn its Motion to Compel, the Commission grants Staff's Motion to Cancel the Motion to Compel, scheduled for May 21, 2021.

THEREFORE, THE COMMISSION ORDERS:

A. Staff's Motion to Cancel the May 21, 2021 hearing on Staff's Motion to Compel is granted.
