# PREHEARING OFFICER ORDER GRANTING INTERVENTION TO CITIZENS' UTILITY RATEPAYER BOARD

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. The Commission has designated Brian Fedotin, Advisory Counsel, to act as Prehearing Officer in this proceeding. Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

- 1. On January 8, 2013, Mid-Kansas Electric Company, LLC filed its Application for approval of a Debt Service Coverage Formula Based Ratemaking Pilot Plan covering the territory served by its member-owner, Southern Pioneer Electric Company.
- 2. On January 10, 2013, the Citizens' Utility Ratepayer Board (CURB) filed a petition to intervene in this docket. In its petition, CURB states the rates paid and the service received by certain residential and small commercial customers may be affected by this proceeding.<sup>1</sup>

- 3. The Commission has broad discretion to grant a petition for intervention if it is in the interests of justice, if the intervention will not impair the orderly and prompt conduct of the proceeding, and if the party has stated facts demonstrating its legal rights, duties, privileges, immunities or other legal interests may be substantially affected by the proceeding.<sup>2</sup> At any time during a proceeding, the Commission may impose limitations on an intervener's participation.<sup>3</sup>
- 4. The Commission finds and concludes that CURB has met the requirements of K.A.R. 82-1-225 and should be granted intervention. CURB will be added to the mailing list, service of pleadings, communications, and correspondence should be delivered to counsel of record, as follows:
