**PREHEARING OFFICER ORDER EXTENDING DEADLINE FOR FILING OF  
SETTLEMENT AGREEMENT**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1.       On August 2, 2018, the Commission issued an *Order Establishing Procedural Schedule* in this matter, setting November 30, 2018 as the deadline to submit a settlement agreement.<sup>1</sup>

2.       On November 29, 2018, via email, Commission Litigation Staff communicated to the Prehearing Officer the parties' request that they be given until December 3, 2018, to file a proposed settlement agreement.<sup>2</sup>

3.       Given that no party expressed an objection to the requested extension and the fact that the extension will not affect any other deadline in the procedural schedule, the Prehearing Officer finds it reasonable to grant the extension. The deadline for submitting a settlement agreement shall be extended to December 3, 2018.
