On April 10, 2025, the Kansas Corporation Commission (KCC or Commission) issued an Order adopting Vantage Point Solutions' (VPS) Audit Report and directed Combined Public Communications, LLC (Combined or Company) to file an affidavit attesting that the Company had corrected its billing system to use the correct assessment rate for the appropriate fiscal year. This action was to be taken within 30 days of the issuance of the Order, or May 12, 2025.

On May 2, 2025, Combined provided VPS with the affidavit, signed by an officer of the Company, attesting that the Company corrected its billing system to use the correct assessment rate for the appropriate fiscal year. VPS filed the affidavit in the Docket, on behalf of the Company.

VPS recommends that the Commission determine Combined is in compliance with the Commission's Order and that Docket No. 25-CPBC-105-KSF be closed.
