## STATUS UPDATE TO COMPLIANCE AGREEMENT

On October 8, 2019, the Commission issued an Order Approving Compliance Agreement in this docket. The Agreement provides that the Agreement may be amended to include additional wells with the written consent of the District Supervisor.<sup>1</sup>

The District #2 Supervisor recommends amending this Agreement to include the Evans #1, API #15-113-20736; D Peterson #1, API #15-113-20786; Peterson #1, API #15-113-20642; Waln #1, API #15-113-20629; and Waln #2, API #15-113-21159 wells (Subject Wells). Operator has expressed a desire to address the Subject Wells and is not opposed to the addition of the Subject Wells to the Agreement. Further, Staff recommends the final compliance deadline be extended to May 1, 2023.
