**WITHDRAWAL OF MOTION TO SUSPEND INTRASTATE
MOTOR CARRIER OPERATIONS**

The Staff of the State Corporation Commission of the State of Kansas (Staff), by and through its counsel, files a withdrawal of its motion to suspend Campbell Transport LLC, of Overland Park, Kansas (Carrier) from intrastate commercial motor carrier operations. In support of its Withdrawal, Staff states as follows:

1. On August 12, 2025, the Commission issued Carrier a Penalty Order that assessed a civil penalty of \$300 for failure to pay the Unified Carrier Registration (UCR) fees for 2025 by January 1, 2025, as required by 49 C.F.R. 367.50 and adopted by K.A.R. 82-4-30a.
2. Carrier was sent a collection letter on September 17, 2025, reminding it of the amount due and giving it 10 days from the date of the collection letter to pay.
3. As of October 17, 2025, Commission records indicated that Carrier had not complied with the collection letter or the requirements of the Penalty Order.
4. On October 17, 2025, Staff filed its Motion to Suspend Intrastate Motor Carrier Operations.
5. On October 17, 2025, the Carrier contacted Staff and stated that Carrier is no longer operating. Staff inactivated the Carrier USDOT Number.

6. The Carrier's inactivation of its USDOT Number obviates the need to suspend the Carrier's intrastate motor carrier operations. Therefore, Staff withdraws its motion.

WHEREFORE, for the reasons stated above, Staff respectfully withdraws its Motion to Suspend Intrastate Motor Carrier Operations.
