**STATUS UPDATE ADDING WELLS TO COMPLIANCE AGREEMENT**

On July 8, 2021, the Commission issued an Order Approving Compliance Agreement (Agreement) in this docket. The Agreement requires Operator to bring 26 wells into compliance with K.A.R. 82-3-111 by bringing 2 wells into compliance by December 31, 2021, and two wells into compliance per quarter thereafter.<sup>1</sup> On September 21, 2023, two wells were added to the Compliance Agreement, extending the compliance deadline to March 31, 2025. To date, Operator has brought 18 wells into compliance.

The Agreement provides that it may be amended to include additional wells with the written consent of the District Supervisor.<sup>2</sup> The District #3 Supervisor recommends amending this Agreement to include the Birkett #1, API #15-073-01320; Birkett #2, API #15-073-01321; Birkett #4, API #15-073-01322; Birkett #5, API #15-073-01323; Birkett #6, API #15-073-01324; Birkett #7, API #15-073-01325; Birkett #10, API #15-073-01326; Birkett #13, API #15-073-01327; Birkett #14, API #15-073-01328; Birkett #15, API # API #15-073-01329; Welsh #11A, API #15-073-01340; Welsh #26A, API #15-073-20101; Welsh #29A, API #15-073-21067; Welsh #3, API #15-073-01337; Welsh #4, API #15-073-01338; Welsh A #18A, API #15-073-01351; and Welsh A #2A, API #15-073-01346 (Subject Wells). Operator has indicated it is not opposed to the addition of the Subject Wells to the Agreement. Further, Staff recommends the final compliance deadline be extended to June 30, 2027.
