Any party that fails to attend or participate in the Prehearing Conference, hearing, or other stage of this proceeding may be held in default pursuant to KAPA.

E. A corporation shall appear before the Commission by a Kansas licensed attorney. BY THE COMMISSION IT IS SO ORDERED.
