ORDER ACCEPTING AND ADOPTING COMPLIANCE REPORT AND CLOSING DOCKET

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and record, and being duly advised in the premises, the Commission finds and concludes as follows:

- 1. On August 1, 2017, the Commission directed GVNW Consulting, Inc. (GVNW) to perform an audit of Tempo Telecom, LLC (Tempo) for the Kansas Universal Service Fund (KUSF).
- 2. On June 29, 2018, GVNW filed its Audit Report finding Tempo had a reporting deficiency as a consequence of not recognizing revenue it received from the federal lifeline program for the period of July 2016 through March 2018. Accordingly, Tempo was directed to make payment of \$3,810.16 in an Order dated July 26, 2018, and to submit Audit True-up reports for the period of July 2016 through March 2018 within 30 days of the issuance of the Order.
- 3. On September 5, 2018, GVNW issued a Compliance Report indicating Tempo remitted payment of \$3,810.16 on August 17, 2018, and submitted the required Audit True-up reports within the 30 day filing period.

4. The Commission has reviewed GVNW's Compliance Report filed in this matter and finds it should be adopted and the docket closed.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

- A. The Commission accepts and adopts GVNW Consulting, Inc.'s Compliance Report filed on September 5, 2018, and this docket is hereby closed.
- B. The Commission retains jurisdiction over Tempo Telecom, LLC and the subject matter of this docket for the purpose of issuing such additional orders as it may deem necessary.
