
Comes now Hawkins Oil, LLC in support of its Application in the captioned matter and state as follows:

1. Applicant is an Oil and Gas producer authorized to do business in the State of Kansas.
Hawkins Oil, LLC 427 S Boston Ave Ste 915 Tulsa, OK
2. Applicant has been issued by the Kansas Corporation Commission an Operator's License (32693), expiring on 7/16/2018
3. Applicant is the owner and operator of the Appleman #4 well. API # 15-015-21004, Located NW NE NW 4927 FNL 3599 FWL SE corner T25s R5e Sec 31, Butler County, Kansas. The subject well is located on an active oil and gas lease.
4. Pursuant to K.A.R. 82-3-111, the well was shut in and TA'd in 4/2008. The well has maintained such status from 4/2008 to 9/2018.
5. On 12/15/2017, the Kansas Corporation Commission notified the applicant temporary abandonment status for the subject well should be denied from and after 12/15/2017 because the 3-year extension has expired.
6. K.A.R. 82-3-111 imposes a 10- year limitation on the amount of time during which wells may be temporarily abandoned, but an exemption to the 10-year limitation may be obtained pursuant to said regulation through an Application filed with the Commission pursuant to K.A.R. 82-3-100. Applicant seeks such an exception.
7. On 12/19/2017, the subject well passed a Commission Staff-Witnessed mechanical integrity test of the casing surface and total depth.
8. Applicant wishes to continue TA status for the subject well, because more time is needed to evaluate the well for conversion to a disposal well.

9. Applicant submits the following information regarding the well in support of the Application.
 - a. The lease consists of (7) wells – 1A PR, 4A TA, 6A PR, 7A AI, 9A PR, 13APR, and 15A PR.
 - b. The estimated cost of plugging each well is 13,500.
 - c. Current rate of production is 2.25 bopd.
 - d. Estimated reserves are 55,500 bbls.
10. Applicant has included a plat map showing the locations on the same leased premises as the subject well.
11. Based on the foregoing, Applicant requests the Commission grant an extension to allow the well to remain eligible for temporary abandonment status for three (3) years, but Applicant understands that the exception would be valid for (3) years, but Applicant would need to apply to the Conservation Division Office for approval for an application for temporary abandoned status.
12. Listed in the attached Exhibit "A" are the names and addresses of the following persons:
 - a. Each operator of each oil and gas lease covering lands within (1/2) mile radius of the subject well: and
 - b. Each person who owns any mineral interest of record in and under any located within (1/2) mile radius of subject well.
13. Notice of this Application will be published pursuant to K.A.R. 82-3-135a. In addition, notice of the hearing to be held on the matter will be provided as prescribed by K.A.R. 82-3-135.

WHEREFORE, Applicant asks that this matter be granted admiratively without a hearing, or in the alternative be set for hearing, and upon hearing that the Commission Grant Applicant's request for a (3) year extension, to allow the subject well to remain temporally abandoned subject to annual approval by the Conservation Division District Office of an application for temporary abandonment status.

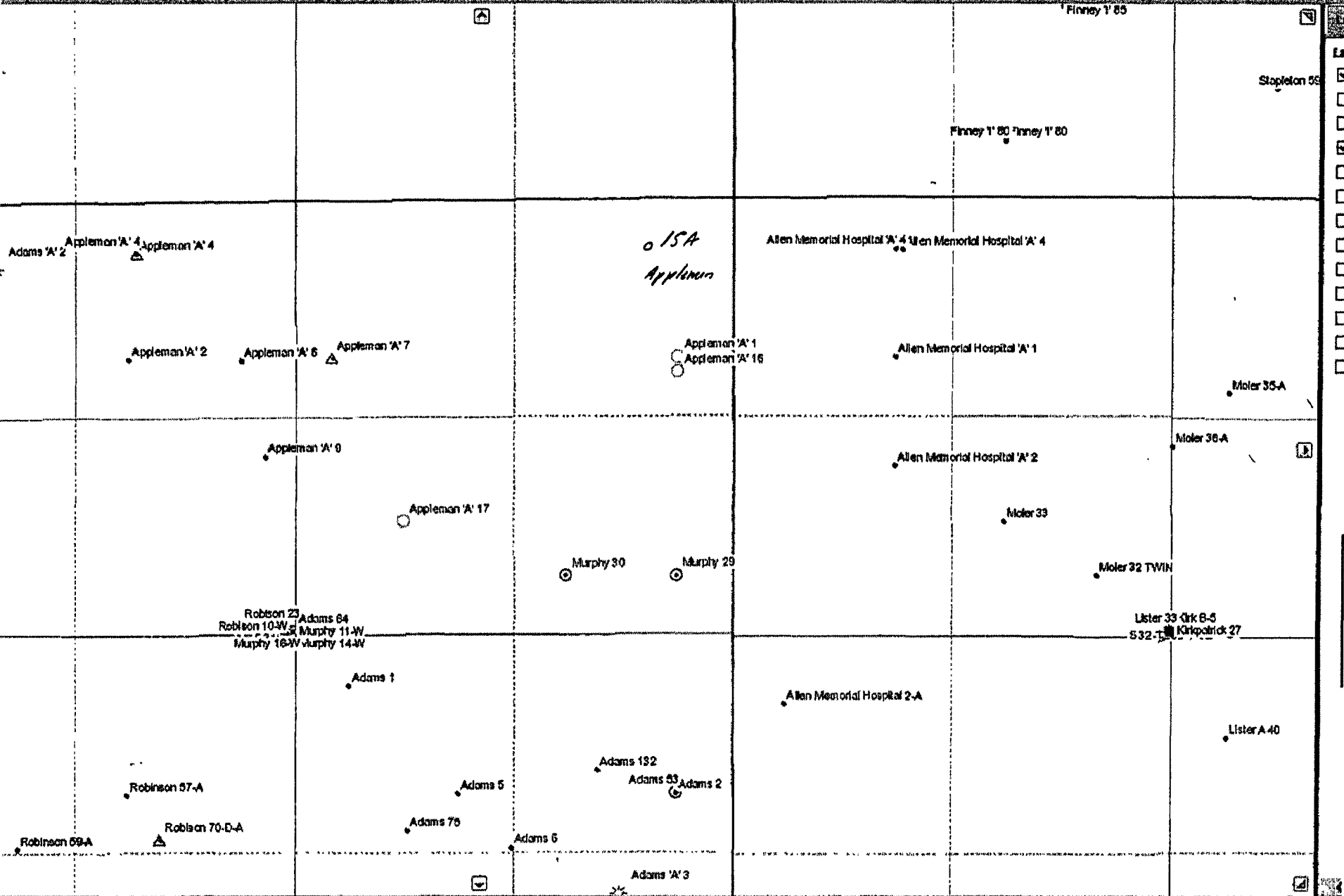
