Re: Atmos Energy Ad Valorem Tax Surcharge; Calculation of 2019 Adjustment

Dear Ms. Retz:

The Commission's March 18, 2005, Order in Docket No. 05-ATMG-693-TAR approved Atmos Energy's Ad Valorem Tax Surcharge Rider ("ATSR"). The order instructed Atmos Energy to file an annual true-up in December of each calendar year and charged Commission Staff with reviewing the filing to ensure the surcharge's reasonable application and proper calculation.

This letter transmits the required true-up, including previously unrecovered/over-received Ad Valorem taxes charged to Atmos Energy plus the recently received 2018 assessments. We have calculated the 2019 surcharge to be charged/refunded to Atmos Energy's sales and transportation customers, as specified under the ATSR.

Attachment 1 is a spreadsheet showing the calculation of the new surcharge to be reflected on customers' bills beginning with February 2019 cycle 1 billings. Attachment 2 is an itemized listing of taxes assessed by each taxing entity. Two CDs containing the supporting documents will be hand-delivered to the Utilities Division.
