PRESIDING OFFICER ORDER SETTING PROCEDURAL SCHEDULE

This matter comes before the Presiding Officer for consideration and decision. The Presiding Officer finds the following:

1. On December 21, 2021, the Commission issued a penalty to Mast Trucking totaling

\$6,500 in civil fines comprised of four alleged violations.¹ The four alleged violations included a \$5,000 enhanced fine for allowing or permitting drivers to falsify records of duty status. Mast Trucking previously received a penalty for the same violation by Penalty Order dated March 10, $2020.^2$

2. On December 23, 2021, Mast Trucking filed a request for hearing.³

3. On June 27, 2022, Staff of the State Corporation Commission of the State of Kansas

("Staff") filed a Motion to Set Prehearing Conference to be scheduled between the parties for setting a procedural schedule and hearing date.⁴

4. On August 2, 2022, a Prehearing Conference was held. The parties and the Presiding Officer agreed on the following Procedural Schedule.
