Dear Jim:

Please be advised there is a corner system on the property. I would suggest never digging on the property without contacting the Roenbaughs. There are buried wires to control the irrigation sprinkler.

As per our phone conversation, here is what is planned for the Southwestern College #11 well on this property:

- It is your intention to move a work over rig to the property between now and February 15, 2015. At that time, you will swab test the Kinder hook formation to see if there's any gas or oil. If the swab test is good, you might try to produce the well for natural gas to run the pumping unit rather than purchase propane.
- 2. Please be advised, this property will be in corn in 2015. It will be necessary to have all of your equipment out of the way of the irrigation sprinkler not later than March 15, 2015. I am providing this information to you for your planning process. Based on Mr. Roenbaugh's intentions, as soon as the cattle are off the property, Mr. Roenbaugh will begin his spring tillage. After spring tillage, the sprinkler will be running.
- 3. As per a letter from the State of Kansas, Kansas Corporation Commission, they will not grant you an additional period of time for the temporary abandonment (TA) for this well. If you are going to plug the well, it would be my suggestion to plug the well over the winter of 2015-2016. Mr. Roenbaugh's sprinkler will not reverse. With this said, there could be a tremendous amount of damage to his crop by not being able to irrigate the property. I provide this information to you for your planning.

- 4. A copy of this letter is going to Mr. Roenabaugh. Mr. Roenbaugh will be able to contact you or your pumper in order to keep abreast of what is going on at the Southwestern College's #11 well. I have sent Mr. Roenbaugh the file information as to the Kansas Corporation Commission's determination.
- 5. It would be Mr. Roenbaugh's intention to plant corn on this property about April 1-10, 2015. I provide this for your planning purposes. Mr. Roenbaugh would request everything be off the property, the barricades up and this will allow him to continue the irrigation on the property.
- 6. You might remind your pumper no cutting the corners on the lease road from the Southwestern College's producing well on the east side. It is been your pumper's habit over the last 5 years to cut the corner, drive through the corn and not pay attention to what is going on.
