REQUEST FOR UPDATE ON STATUS OF COMMISSION’S INVESTIGATION

COMES NOW Complainant, Shelia D. Hudson (“Hudson”), by and through her counsel Sean M. McGivern, of Graybill & Hazlewood, LLC, to request that the Commission provide a status update on the pending matter.

1. In April 2024 Hudson’s service was disconnected by Evergy Kansas Central, Inc. (“Evergy”) for non-payment based on Evergy’s inconsistent records.
2. On or about August 8, 2024, Hudson filed a complaint in this matter with the Commission and provided several examples of inconsistent account histories that Evergy provided to her.
3. The Commission served the Complaint on Evergy in an Order on August 15, 2024.
4. Evergy filed its Answer on August 22, 2024.
5. Commission staff informally advised that a staff report would likely be completed in October or November 2024.
6. As of January 6, 2025, there has not been a staff report filed.
7. The City of Wichita is enduring a winter storm and it’s currently freezing.
8. Ms. Hudson respectfully seeks to hear from the Commission the status of its review of her complaint.

WHEREFORE, Shelia D. Hudson requests a status update and any such remedies and relief the Commissions finds just and reasonable.
