**ORDER DESIGNATING NEW PREHEARING OFFICER**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds the following:

1.       On October 29, 2018, RedBud Oil & Gas Operating, LLC (Operator) filed an Application to authorize injection of natural gas into the Cattleman formation at the Westfall #2E-12 well, located in Montgomery County, Kansas.<sup>1</sup> A hearing on the Application is currently scheduled for April 18, 2019.<sup>2</sup>

2.       The Commission designates Jonathan R. Myers, Assistant General Counsel, 266 N. Main Street, Suite 220, Wichita, KS 67202, 316-337-6245, [j.myers@kcc.ks.gov](mailto:j.myers@kcc.ks.gov), as the new Prehearing Officer.<sup>3</sup> The Prehearing Officer may conduct Prehearing Conferences necessary to address any appropriate matters, including all items listed in K.S.A. 77-517(b) of the Kansas Administrative Procedure Act (KAPA). The Commission may designate other Staff members to serve in this capacity.
